A. ORDINANCE 2021-12: ZONING CHANGE: 202-10-057 & 046B: JAYMESON WILCOCK: FROM RESIDENTIAL TO MULTI-FAMILY SO THAT MULTI-FAMILY DWELLINGS CAN BE CONSTRUCTED

Motion by Perkins, 2nd by Lewis, to approve Ordinance 2021-12, rezone from residential to multi-family. Motion passed; 5-1 with Johnson L opposed and with Johnson C absent

B. ORDINANCE 2021-13: ZONING CHANGE: 202-36-040: SAM ROSALES: FROM AG TO R-2 SO THAT THE LAND MAY BE SPLIT INTO TWO PARCELS THEN A DOUBLE WIDE MANUFACTURED HOME WOULD BE PLACED ON EACH PARCEL

Joe presented the item; the P&Z Commission heard this item and after hearing from parties supporting and opposing, they voted to recommend approval for R-2 zoning.

Motion by Lewis, 2nd by Ballard, to approve Ordinance 2021-13, rezone from AG to R-2. Motion passed; unanimous with Johnson C absent\

C. SPECIAL USE PERMIT: BONNIE HEAL: 202-07-057: CREATION OF A FAMILY BURIAL

#### PLOT ON THE PROPERTY

Joe presented the item; the P&Z Commission heard this item after the applicant finished other required steps. The commission recommends approval of this item. Staff has done additional research to ensure all the requirements have been met, and they have.

Johnson L- close to the property line, any issues?

Joe- notice was given to all property owners; 3 of the neighbors responded and were in favor of the request

Brimhall- is the rockiness of the area an issue?

Joe- it was mentioned that it was difficult to dig

Motion by Johnson L, 2nd by Flake, to approve Special Use Permit for the creation of a family burial plot. Motion passed; unanimous with Johnson C absent

D. SPECIAL USE PERMIT: 202-46-007: ANGHARAD REES: INSTALL AN ADDITIONAL SINGLE WIDE MANUFACTURED HOME

Joe presented the item; the P&Z Commission heard this item and recommends approval. The neighboring properties were informed, and he did not receive any complaints against the application.

Perkins- this area allows single wide homes because of the zoning it is in? correct

Motion by Flake, 2nd by Brimhall, to approve Special Use Permit to install an additional single wide manufactured home. Motion passed; unanimous with Johnson C absent

E. GOLF COURSE GRANT AWARD

Brian presented the information for the grant award for the new water well.

Lewis- how will this decrease the water bill? Brian- it won't change the utilities very much

Motion by Johnson L, 2nd by Perkins, to approve the budget and accept the grand award. Motion passed; unanimous with Johnson C absent

F. GENERAL PLAN BACKGROUND AND CURRENT CONDITIONS REPORT approve the general plan background and current conditions report,

Motion by Ballard, 2nd by Flake, to approve the General Plan background and current conditions report. Motion passed; unanimous with Johnson C absent

G. RESULTS OF THE GENERAL PLAN SURVEY

No action needed.

149 people responded- they provided a really good base; affordable housing and recreation were in the forefront; the representation of the people responding isn't a perfect representation, but it gives a good idea. Would like staff to remember that citizens have asked for more outdoor recreation.

H. SNOWFLAKE BOULEVARD GRANT AWARD AGREEMENT NUMBER EMF-2020-PC-0001

Brian presented the grant project information; ~\$225,000 with a match requirement; will have until April 1, 2023, to finish the project. It will take care of maintenance and safety issues in the area. Looking to get funds from the county and the silver creek flood protection district for this project as well. This was designed by Oracle Engineering. This won't solve the flooding issue, but it will make maintenance of weeds and debris easier and cheaper.

citizen- would like the town to study further down at the cottonwood wash

Johnson- the town doesn't have responsibility for the creek, but the things we plan to do are within our control; the town is doing the most that we can do to remediate any damage in the area under our authority; appreciate your observations

Motion by Lewis, 2nd by Johnson L, to approve Agreement Number EMF-2020-PC-0001, Snowflake Boulevard Grant. Motion passed; unanimous with Johnson C absent

I. RODEO GROUNDS BIKE PARK GRANT AWARD

The location of the bike park has changed, so if there is anyone that is in opposition to rodeo grounds location that isn't a consideration at this time:

Ballard moved to table the item due to the fact that the agenda has the bike park at the rodeo grounds, but he withdrew his motion after considering that the location has been amended and the tourism grant needs to be approved.

Motion by Lewis, 2nd by Ballard, to approve the grant funds independent of location. Motion passed; unanimous with Johnson C absent
