In the event of failure on my part to comply with the terms and conditions of this agreement, I agree that the Town of Snowflake Utilities or its representative may discontinue service hereunder without notice to me, and that such discontinuance will not constitute waiver of any claims against me for prior service rendered by the Town of Snowflake Utilities.
