

## RESOLUTION NO. 2026-17

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF SNOWFLAKE, NAVAJO COUNTY, ARIZONA, CANVASSING THE RETURNS AND DECLARING AND ADOPTING THE OFFICIAL RESULTS OF THE PRIMARY ELECTION HELD ON THE 21<sup>st</sup> DAY OF JULY 2026; AUTHORIZING THE TAKING OF ALL OTHER ACTIONS NECESSARY TO CARRY OUT THE PURPOSE AND INTENT OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE OF THIS RESOLUTION.**

**WHEREAS**, the Town of Snowflake, Navajo County, Arizona, did hold a Primary Election on the 21<sup>st</sup> day of July 2026 for the purpose of electing a Mayor to one 4-year term and electing two Council Members to 4-year terms; and

**WHEREAS**, pursuant to A.R.S. §§ 9-821, 9-821.01, and 16-642, upon receiving the results from Navajo County which conducts the Town's elections, the Town Council shall canvass the returns and declare the results of the Primary Election, pursuant to the statutory formula required by A.R.S. § 9-821.01 and Section 1-5-2(A) of the Town Code, and issue certificates of election or nomination as appropriate; and

**WHEREAS**, A.R.S. § 16-642(A)(3) requires that the Town hold a meeting to adopt a canvass of the Primary Election not less than six (6) days nor more than twenty (20) days following the election with such information as required by A.R.S. § 16-646(A); and

**WHEREAS**, the returns of the Primary Election have been presented to and have been canvassed by the Town Council pursuant to state law.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Town of Snowflake, Navajo County, Arizona as follows:

**SECTION 1:** That the total number of ballots cast at said Primary Election, as reported by Navajo County was 1,311; and, the total number of active registered voters was 4,290, for a turnout of 30.56%.

**SECTION 2:** That, pursuant to A.R.S. § 16-646(A), Exhibit A, attached hereto and incorporated herein by reference, is adopted as the Official Canvass for the July 21, 2026 Primary Election and sets forth the number of votes cast, the names of the persons voted for, the number of votes received in each precinct by each candidate, and such other election results as required by law; and the number of ballots rejected in each precinct is set forth in Exhibit B, attached hereto and incorporated by reference.

**SECTION 3:** That the votes cast for the candidates for the Office of Mayor for a one 4-year term is as follows:

**SECTION 7:** This resolution shall be in full force and effect immediately upon its adoption.
